

## Dear families and friends:

We are writing with some very encouraging news. On Saturday February 6, 2021, we received an update from OPWDD Commissioner Kastner, that "the recent expansion of prioritization in the New York State vaccination rollout now includes all people with intellectual and developmental disabilities."

Beginning Monday, February 15, 2021, individuals with intellectual and developmental disabilities will be eligible to receive the COVID-19 vaccine. See attached communication. Governor Cuomo announced yesterday that you can begin scheduling your vaccinations on Sunday, February 14. To qualify for the vaccination under the expanded criteria, New Yorkers must provide documentation as required by the facility where they are getting vaccinated. This could include a doctor's letter, medical information evidencing an intellectual/developmental disability, or a signed certification to the like. When scheduling, please be sure to ask what documentation the facility requires, we may be able to assist you with securing documentation that may be in our records or that we may be legally entitled to generate.

While access to the vaccine is not without its challenges, this prioritization provides an avenue to get the vaccine if you are able to access an appointment. While gaining an appointment may prove challenging, it is achievable. It is our hope that the information we provide today and in the future will be a resource for you and your family member(s) toward identifying and securing the vaccination. Please take the time to explore the links below as they may prove to be helpful toward that objective.

## UPDATE RE: COVID-19 Vaccine for People With Developmental Disabilities Living at Home

Dear Friends and Colleagues:

On February 5, 2021, Governor Andrew M. Cuomo announced that people with intellectual and developmental disabilities living in non-certified settings will be added to the 1b prioritization category and will be I am pleased to share that the most recent expansion of prioritization in the New York State vaccination rollout now includes all people with eligible to receive COVID-19 vaccines as of February 15, 2021.

Additional Access to the vaccine has been a challenge across the country and we will continue to work diligently to ensure that all people supported by guidance related to the announcement about newly eligible populations will also be posted in the coming days. I would like to emphasize that, while it is up to each person to choose to receive the vaccine, the more people who receive the COVID-19 vaccine, the better the public health outcome will be. Answers to some frequently asked questions about the safety and efficacy of the COVID-19 vaccine are available at the Department of Health website as well as information about the benefits of the vaccine, and the federal approval process As valued members of our OPWDD community, I appeal to every one of you to help educate others about the importance of this vaccine and to do your part to encourage widespread vaccination. And please remember that the threat of COVID-19 is far from over. Even after you receive the vaccine, please continue to follow guidance on social distancing, avoid crowds, wear a mask in public and wash your hands frequently.
